PC's Matt and Julia answered questions from Councillors reiterating that Barling has a low crime rate – Wakering has had a high youth nuisance with motor vehicle thefts in the past but was now quieting down – Barling is included in the Wakering figures - a public meeting in the Old School, High Street, Wakering on the 6th March 2013 to discuss local police matters - Councillors Mrs I Knight and Mr A Jones posed speeding problem questions re: the local roads where they live – Matt agreed to approach local stables to emphasize the need for awareness of local road conditions
