Minutes of the meeting of the Barling Magna Parish Council held on Thursday 26th May 2016 held in All Saints Church, Church Road, Barling Magna, Essex commencing at 7.30 p.m.

MINUTES

- 1. The Chair to declare the meeting open
 - a. Cllr Steptoe declared the meeting opened
- 2. To elect a Chair of Barling Magna Parish Council for 2016/2017 Term of Office
 - a. Cllr Cohen was proposed by Cllr Pearmain and seconded by Cllr Gardiner
 - b. Cllr Steptoe was proposed by Cllr Edmunds and seconded by Cllr Ashdown
 - c. Cllr Cohen received 5 votes and Cllr Steptoe received 4 votes, therefore Cllr Cohen was duly elected as Chair for 2016/2017 Term of Office

3. To elect a Vice-Chair of Barling Magna Parish Council for 2016/2017 Term of Office

- a. Cllr Steptoe was proposed by Cllr Cohen and seconded by Cllr Street
- b. Cllr Gardiner was proposed by Cllr Pearmain and seconded by Cllr Knight
- c. Cllr Steptoe received 5 votes and Cllr Gardiner received 4 votes, therefore Cllr Steptoe was duly elected as Vice-Chair for 2016/2017 Term of Office
- 4. The elected Chair and Vice-Chair of the Parish Council to make the Statutory Declaration of Acceptance of Office
 - a. Both declarations were signed
- 5. Individual Councillors to update their register of interests
 - a. None were required

- a. Councillor Steptoe declared an interest regarding Planning and as a member of the Local Highways Panel as part of his district responsibilities and in Barling Magna Primary School as a Community Governor

13. To receive a report from the District and County Councillors for the area on any matters of interest.

- a. Cllr Steptoe advised that he had been elected as Deputy Leader for RDC
- b. That Amar Dave Chief Executive of RDC will be leaving at the end of June and details on his replacement will be announced in time
- c. Christine Lyons the Assistant Director for Planning Services is also leaving at the end of June and her vacancy will be filled
- Cllr Steptoe, Cllr Williams and Cllr Lucas-Gill were elected for Roche South Ward at the elections on 5th May and the ward covers the 3 parishes of Barling, Sutton & Rochford

14. Financial Matters to consider and approve

- a. Payments were agreed
- b. As the Village Hall is not in use, it was agreed for the clerk to contact the Broadband Supplier and suspend the service. Proposed Cllr Edmunds, seconded Cllr Gardiner. Carried unanimously.
- c. ACTION Clerk to contact supplier and report back to council

15. Appointment of Auditors

- To confirm the re-appointment of Auditing Solutions Ltd as Internal Auditors to Barling Magna Parish Council for the year to 31st March 2017
- b. Proposed Cllr Steptoe Seconded Cllr Pearmain. Carried unanimously.

16. Clerks Report

- a. Still awaiting outcomes of funding bids submitted
- b.The clerk reminded the council that the role is 15 hours a week and that responses to emails etc. will be dealt with as quick as possible during the working hours

- a. Cllr Steptoe and Cllr Edmunds declared an interest in this item
- b.Discussions were had about should we be supporting the school and prioritising our funding is important
- c. The request was for £200 towards book marks, so that every child received a souvenir of the Queens 90th Birthday
- d.Proposed Cllr Pearmain, seconded Cllr Ashdown. 2 abstentions. Carried

- a. Cllr Street made a point of order that Standing Orders cannot be amended without a special motion. Note s/o 25b.
- b. Cllr Steptoe explained that he had asked the clerk to approach other parishes and ask how they manage external speakers and proposals were read out.
- c. It was decided that this would be discussed at a future meeting
